NOTICE – REVISED FEES STRUCTURE FOR SESSION 2020-21

The recent pandemic all across the country and the world has devastated the entire socio economic balance which has affected the schools, the entire education system, the academics and the students by and large to a very major extent.

The onslaught of the pandemic is such drastic and severe that months together the school management were devoid of monthly fees resulting in huge dues from the parents thereby crippling the schools to even run on optimum to carry out the societal responsibilities of arranging online classes as per Board/State/Central Govt. dictum to desperately maintain the equilibrium amidst an enormous imbalance.

The Hon'ble High Court of Kolkata genuinely stood by the distress of the guardians and vide its Order dated 13th October 2020 allowed an exemption of 20% applicable on the fee structure of **Session 2019-20**.

North Point Senior Secondary Boarding School had been a decided relief to the guardians all through, much before the Hon'ble Court was moved, to extend best of the relief possible by the school.

Recently Guardians of all classes were called, explained in detail about the leave granted by the Hon'ble High Court and were left to make their decision in regard to the school fee.

With immense pride North Point Senior Secondary Boarding School put forward that the majority of the guardians opted to stick to and adhere to the fee structure/module drawn by the school pertaining to academic session of 2019-20. However, the aspect of availing the Exemption of 20% allowed by the Honorable High Court has been kept open for one and all.

The immaculate bond between the guardians and the management has become exemplary in today's scenario wherein the guardians have duly paid back the school the coveted reward of treating the entire segment all through, since inception, as a family.

Salient points related to fees were decided for implementation with immediate effect:-

1. Fees structure of 2019-20 will be followed. Hence adjustment of fees shall be effective from **April 2020**.
(Please follow the Fees chart as given while making the payment).
2. It is an appeal that in reference with Para 61 Point no. Vii of the directions by the Honorable High Court, Kolkata on 13.10.2020, read as, "parents and guardians of students are requested not to avail of the reduction in the School fees if their financial situation doesnot merit the reduction..." we would like to appeal to all the parents to continue paying the fees as per the chart without 20% reduction if your financial situation allows you to do so.

3. A parent availing **20% reduction in fees** must clear all the dues by **30th November 2020** as per High court order dated 13.10.2020. The same have to be continuous for following month(s) too. In this regard, with effect from 8th December 2020 the school shall be entitled to disallow students whose fees have not been paid in full.
4. In case a Parent **does not avails 20% reduction**, and they want to continue with relaxation of **EMI facility** given by school, the concerned parents are requested to clear all dues by **31st March 2020**.

However for Class 10 & 12, the fees must be cleared before commencement of Board Examinations. There shall be no exception in this matter.

5. The above facility of EMI shall be extended to only those Parents who have cleared fees for the 1st quarter (**Apr –Jun 20**). Those who have not paid any fees from April/May 20, they have to clear all the dues upto November 2020 by 30th November 2020 positively as per the 20% fees reduction chart.
6. The above facility of exemption of 20% reduction in fees, **OR**, EMI facility extended by the School **shall not be applicable** to any Parent who are already availing concessions in fees in the school.
7. Those parents/guardians who couldn't attend the meetings in respective branch, are required to submit the duly signed **declaration form** (whether they would Opt 20% reduction in fees **OR**, they want to avail the EMI facility as provided by the school). This must be complied by **25th November '2020** to respective branches so as to enable the school to adjust the fees accordingly. In case any parent is unable to come to school within the aforementioned date due any reasons, they may positively contact the school and get the declaration form and submit immediately.
8. In case of **non-receipt of declaration** from any particular parent within the date as mentioned above i.e. **25th November 2020**, it would be presumed that the concerned parent(s) are opting for 20% reduction in fees for the year 2019-20, and instructions as enumerated in point no. 3 shall be applicable for that parent.
9. Parents due for submission of declaration form may send email to npsarjunpur@npssbs.org.in seeking declaration form citing which fees option they want to opt.

IMPORTANT POINTS TO NOTE:

1. **In case any parent have already paid fees from April till October/November or December as per the previous fees structure of 2020-21, then they are requested to kindly get the excess amount as per the chart adjusted in the following month from the accounts department.**
2. **Parents are requested not to make any payment through "School Mobile App" till further notice, and they may pay manually through CASH, NEFT, IMPS, etc. and send the details to school email.**
3. **Fees Receipt Shall be generated only after verifying receipt of **declaration forms** from the concerned parents.**
4. **No Refund of fees shall be done under any circumstances. Any excess paid amount shall only be adjusted with the fees.**
